1) Pastor Paul Kibler Endowment

FUND PURPOSE: The Fund shall be used for support of the religious, charitable and educational purposes of Organization and to enable Organization to carry out its role and mission as described in its governing documents. *Specifically, the Fund shall be used to provide tuition assistance to students attending Resurrection Lutheran School.*

2) Resurrection Lutheran Church Endowment

FUND PURPOSE: Request for funds must meet the criteria listed in one of the six categories below:

- 1. The RLC Endowment Fund (Fund) may be used to help other LCMS churches as they get started;**
- 2. The Fund may respond to national or international needs or disaster;**
